At its meeting of May 16, 2013, the Board of Public Works, acting in their capacity as Sewer Authority, voted to enact the following rate structure for the Wastewater Facilities User Charge, effective July 1, 2013. Said rate structure was placed on file with the City Clerk's Office on May 20, 2013. Any appeals to these charges must be submitted within 21 days of the filing to the Sewer Authority, 111 North Main Street, Bristol, CT 06010. Payments will be received quarterly in accordance with the standard billing periods of the Bristol Water Department.

Wastewater Facilities Rate Structure

I. User Fees

Category (A) Residential

based on winter water consumption billings of February 1, March 1, April 1
minimum quarterly consumption basis 1,000 c.f. (7,480 gallons)

standard quarterly consumption basis for unmetered services (well supply) 2,100 c.f.
(15,708 gallons)

Category (B) Commercial/ Industrial (4 or more dwelling units)

based on actual metered water consumption (subject to individual adjustment for
supplemental supply wells or discharge through valid NPDES Permit)

Rate for Categories A and B:

\$2.116 per 100 cubic foot of water used (748 gallons)

Category (C) Commercial/ Industrial Excess Treatment Surcharge

Allowable effluent limits in milligrams/liter

Suspended Solids 218

BOD 167

Ammonia 18

Rate for Category C: surcharge applied to discharges in excess of the above allowable effluent limits.

Suspended Solids \$.40 per lb.

BOD \$.48 per lb.

Ammonia \$.42 per lb.

Category (D) Septage Disposal

Septage generated within the City of Bristol and the Towns of Burlington, Plymouth/Terryville, Wolcott and Southington discharged by a licensed contractor shall be charged at the rate of \$0.070 per gallon.

II. Permit & License Fees

A.) Connection Charges (Capacity utilization)

- (a) Residential \$1,200.00 per dwelling unit;
- (b) Commercial/ Industrial \$166.00 per fixture unit for the first 250 fixtures
\$65.00 per fixture thereafter
\$1,200.00 minimum charge

B.) Septage Dumping License

- (a) Company based in Bristol \$ 75.00 per vehicle per year
- (b) Company based outside Bristol \$250.00 per vehicle per year
- (c) Recreational Vehicles & Trailers \$ 10.00 per year

III. Service Fee

Service fee shall be assessed against all users of any category in accordance with the following table:

Users who do not have a public water service will be assessed a Service Fee of \$17.17 per quarter year.
