**Reconnection Fee:** \$500.00 per EDU

## COMMERICAL CONNECTION FEES

**Current:** \$288.00 per fixture

**Proposed:** \$175.00 per fixture (In a meter size format)

**Reconnection Fee:** \$500.00 per EDU (Reconnection fee does not apply in areas of change of zoning classification/change of use)
