(4) **Planning Commission** meets on the 4th Monday of the month, **except as noted** (\*3rd Monday of May 2026).

All meetings will be held in the Bristol City Hall Council Chamber (111 North Main Street).

(5) **Historic District Commission** meets on the 4th Wednesday of the month. (\*3rd Wednesday in November and 3rd Wednesday in December 2026).

All meetings will be held in the Bristol City Hall Council Chamber (111 North Main Street).

(6) Zone changes, use variances and certain Special Permits specified in the Zoning Regulations must be referred to the Planning Commission for a report prior to the public hearing by the Zoning Commission or ZBA.
